



**HMRC Tax Free Childcare
Autumn Term 2024**

(Same applies for Spring & Summer term 2025)

Dear Parents,

Our fees are fully inclusive and include the core day, lunches, before and after school care and after school clubs.

The Government presently allows a parent to claim £2 in every £8 spent for childcare. <https://www.gov.uk/tax-free-childcare> You can get **up to £500** every **3 months** (up to £2,000 a year) for each of your children to help with the costs of childcare.

The typical school day is 10 hours. Start time is at 8am and finish time at 6pm whilst the before school and after school element varies per year groups.

100% of fees = £4,811		
25% of fees = £1,202.75	Morning & After school element	



Prep

Year 3 & 4

Morning care 8.00-8.30am After school care 4.00-6.00pm Total **2.5hrs**
 100% of fees = £5,470
 25% of fees = £1,367.50 Morning & After school element

Year 5 & 6 fees

Morning care 8.00-8.30am After school care 4.00-6.00pm Total **2.5hrs**
 100% of fees = £5,610
 25% of fees = £1,402.50 Morning & After school element

Parents should always double check with HMRC what amount exactly they can pay through vouchers.

As School fees increase slightly at the beginning of each school year the calculations above will be revised next September 2025.
