Our fees consist of the following separate elements:

Education fee including VAT

Lunches

Childcare

The Government presently allows a parent to claim £2 in every £8 spent for childcare. <https://www.gov.uk/tax-free-childcare> You can get **up to £500** every **3 months** (up to £2,000 a year) for each of your children to help with the costs of childcare.

The school is open Monday to Friday, 8am to 6pm, during term time

32.5% claimable = £640.20

32.5% claimable = £741.90

### **Year 5 & 6 morning & after school child care**

Morning childcare 8.00-9.00am  
After school childcare 3.45-6.00pm  
Childcare = £2,349.47  
32.5% claimable = £763.57

*Parents should always double check with HMRC what amount exactly they can pay through vouchers.*

As School fees increase slightly at the beginning of each school year the calculations above will be revised next September 2025.
